### **Cal Rayburn Award History**

The Calvin Rayburn Award was created to acknowledge individuals who have made superior long term service in the field of chemical testing in relation to transportation or workplace safety and have made outstanding contributions to the International Association for Chemical Testing

The award was created to memorialize Calvin M. Rayburn, who was better known to his friends as Cal.

- Cal began his career in chemical testing with the Iowa State Crime Laboratory in 1973 as a urine and blood alcohol analyst. In 1974 he began work in the breath alcohol test program where he spent the next 27 years.
- Cal chose the Intoxilyzer 4011A as the instrument to be used in Iowa for breath testing and the instrument remained in use for the next 27 years.
- Cal was a founding member of the International Association for Chemical Testing.
- IACT was very important to Cal, he was heavily involved in helping IACT to become a successful organization early on.
- Cal and Gil Sapir always had arguments at every IACT business meetings.
- He was involved in the joint IACT/NHTSA research project years ago.
- He served as chairman of the membership committee from 1988 to 1990.
- In 1990 Cal Rayburn was appointed to the Board of Directors where he served through 1996.
- His long term service in the field of chemical testing and his dedication to the success of this organization is memorialized through this award.

### **Cal Rayburn Award Requirements**

To be considered for the Rayburn Award the individual nominated must, through a minimum of ten years as a member of the International Association for Chemical Testing:

- 1) have significant services or contributions to the Association, its goals, activities and programs; or
- 2) long dedicated, and meritorious service as a chemical testing practitioner or administrator of programs of chemical testing in relation to traffic or workplace safety in a national, state or local jurisdiction.

Through long credible service, contributions will have been in one or more of the following areas:

- 1) forensics related to toxicological procedures involving alcohol/drugs techniques;
- 2) action programs including law enforcement, training and education, legislation, public information, intervention efforts;
- 3) scientific research and studies of alcohol/drugs in transportation or workplace safety;
- 4) legal matters involving the prosecution, defense, adjudication, or research of alcohol/drug related cases.
